**Gretchen M. Callas is a trial lawyer who routinely represents publicly traded companies in significant matters involving products liability, class actions, and industrial disasters. She practices out of the Firm's office in Charleston, West Virginia.**

Gretchen is a capable trial lawyer with more than twenty-five years' experience. In 2021, she was on the trial team in *City of Huntington, et al. v. AmerisourceBergen Drug Corporation*, 609 F.Supp.3d 408 (2022). The bench trial over the claims of a City and County who were seeking over a billion dollars to remedy an alleged public nuisance took three months. Gretchen was at counsel table each day and took an active role in the presentation of evidence throughout the trial. The case resulted in one of a handful of defense verdicts in the national opioid litigation.

Her work has taken her to many unexpected places, including underground mine sites. Gretchen knows these on-site investigations are crucial to understanding her clients' cases, where she takes the time to talk to clients and employees, review documents, and get a working knowledge of the physical location. Gretchen put these on-site investigation skills to work while serving as a leader of the defense team that handled the civil litigation resulting from the 2010 Upper Big Branch mine disaster.

Gretchen does more than work, though – she also gives back to the legal community. From 2010 to 2013, she served as a chairperson in the Campaign for Legal Aid of West Virginia and has been a member of the Visiting Committee for the West Virginia University College of Law since 2016.
